This course will be offered as a combined Level I and II course with topics relevant to Water Treatment.

It will provide operators with the basic knowledge of water treatment processes focusing on the practical aspects of plant operations.

The intermediate portion will cover all core areas including:

- Detailed treatment processes and systems
- Emerging technologies
- Mathematics
- Complex chlorine and chemical problem solving involving flow and filtration rates
- Enhanced safety components
- Troubleshooting tips
- Maintenance details
- Introductory management practices.

It will cover a variety of practical applications for Atlantic Canada and is recommended for operations staff who maintain Level I and II facilities.
