The Supervisor is responsible for the management and operation of the assigned treatment facility, staff, pumping station, dams and ancillary assets. Minimum qualifications for this position include a two-year technical program related to Water Treatment or an equivalent combination of related formal education and experience in a water treatment environment may be considered. Minimum of five years' experience in a water treatment environment, and minimum of 2 years of direct supervisory experience in a water treatment environment or related discipline; demonstrable experience in a leadership position or lead role may also be considered. In addition, one must possess Class III or IV Water Treatment Operator Certificate (depending on plant requirements), and a hold valid NS driver's license.
